## **AVA Art Gallery Art Specifications**

### **Artwork Entry Guidelines for AVA Gallery Shows**

Artwork is not juried for entry into judged shows at the AVA Gallery. Artists aged 13 and older are welcome to submit their work.

You may submit up to six pieces of artwork.

### **SHOW FEES:**

- AVA members in good standing: \$5 per entry, up to six (6) entries.
- Non-members: \$20 for the first piece submitted, and \$5 for each additional entry, up to a total of six (6) entries.

Please include your entry fee with the submission of this form.

AVA receives a 25% commission on all sales, so please price your artwork accordingly.

An AVA membership form is included in case you choose to join AVA when submitting your show form. Becoming an AVA member entitles you to member entry fees.

### **AWARDS:**

Cash and ribbon awards will be presented for 1st, 2nd, and 3rd places, as well as a People's Choice award and an Artist's Choice award at the reception. Honorable mentions (ribbons only) may be awarded at the discretion of the judges.

### **ELIGIBLE ARTWORK:**

- Artwork can include paintings, sculpture, photography, mixed media, pottery, textiles, mosaics, stained glass, woodworking, wood carving, or monoprints.
- Artwork must not have been exhibited within the past three years at the AVA Gallery.
- Any piece that has previously won a 1st, 2nd, or 3rd place award at any AVA show is ineligible.
- Entries must be original works of art, created entirely by the entrant. There are no restrictions on the creation date of the artwork; pieces from any period are eligible.

### **PRESENTATION:**

- Artwork must be suitably matted/mounted, framed under glass or Plexiglass, and properly wired for hanging. No sawtooth hangers will be permitted.



- Please place a label on the back of each piece with your name, the artwork title, and the price.
- "NFS" (Not For Sale) items will not be accepted.

**ENTRY FORM INFORMATION:**

Information from the entry form is used for various purposes, including inventory lists and price tags. Once the form is submitted, no changes or substitutions of artwork will be allowed.

An **Antigo Visual Arts Release and Waiver of Liability** form (included) must be on file with AVA before any artwork will be accepted. If you have previously completed this form, it does not need to be submitted again.



**PLEASE NOTE:** AVA needs only one of these forms on file. If you have previously submitted this form there's no need to complete it again.

## AVA RELEASE AND WAIVER OF LIABILITY

Property including any art exhibits on Langlade County Historical Society museum premises or AVA Gallery or any other venue is exposed to risks of harm including but not limited to damage, disappearance, and destruction.
